This Addendum No. 2 forms a part of the Solicitation Documents and modifies, as noted below, the original Solicitation Documents identified above.

This Addendum provides questions received and the County's answers to all potential Bidders:

1. May the bid package be submitted prior to the bid opening date of January 17, 2024?
Response: Yes, the bid may be received prior to the submission deadline, but the bid will not be opened until 2:00 PM on January 17, 2024. When sending the bid please email it to lacbid@lacnm.us with a confirmation email sent to derrill.rodgers@lacnm.us.

2. Attachment A drawings show different base types in the front and side views, what is the preferred base?
Response: The County requires a break away base with the Wadsworth style for all the poles.

3. Clarification is needed on the lump sum item for additional hardware for spare parts, what percentage?
Response: The County would like to receive a full set of spare hardware, 1 for 1.

4. What height are you expecting to receive, exact height on the drawings?
Response: Yes, if the height on the drawing is 11 feet then the County would like to receive a pole measuring 11 feet.

5. What design standards are required?
Response: The design should meet the NMDOT standards. It is the vendor's responsibility to ensure that the pole, hardware, and foundations will meet those standards.

6. Would the provider need to store the pole for the County?

Response: No, storage of poles is not required, Freight is included as bid item 11 on the bid form to identify the cost of transporting the poles to the County.
