## Addendum No. 4

This Addendum No. 4 forms a part of the Solicitation Documents and modifies, as noted below, the original Solicitation Documents identified above.

- 1. County made changes to **bid item No. 20** to clarify work included in this item to avoid duplicate costs. It should be noted that the 2-1½" HDPE conduits will be installed in a shared trench with the bid item No. 7 16-inch D.I.P. class 250 waterline. Therefore, work should not be duplicated for:
  - a. potholing, trenching, bedding, removal of waste excavation, above ground pipe markers, backfilling, compaction, site restoration, all other appurtenances needed for a complete installation. Furnish bedding, backfill, and handhole gravel. (all other materials will be provided by Owner: Pueblo de San Ildefonso).
- 2. County made changes to bid **Alternate No. 1 item No. 1.10** to clarify work included in this item to avoid duplicate costs. It should be noted that the 2-1¼" HDPE conduits will be installed in a shared trench with the bid item No. 1.5 and 1.6 16-inch and 12" D.I.P. class 250 waterline respectively. Therefore, work should not be duplicated for:
  - a. potholing, trenching, bedding, removal of waste excavation, above ground pipe markers, backfilling, compaction, site restoration, all other appurtenances needed for a complete installation. Furnish bedding, backfill, and handhole gravel. (all other materials will be provided by Owner: Pueblo de San Ildefonso).
- 3. County made changes to bid **Alternate No. 2 item No. 2.13** to clarify work included in this item to avoid duplicate costs. It should be noted that the 2-1½" HDPE conduits will be installed in a shared trench with the bid item No. 2.5 12-inch D.I.P. class 250 waterline. Therefore, work should not be duplicated for:

a. potholing, trenching, bedding, removal of waste excavation, above ground pipe markers, backfilling, compaction, site restoration, all other appurtenances needed for a complete installation. Furnish bedding, backfill, and handhole gravel. (all other materials will be provided by Owner: Pueblo de San Ildefonso).

All other provisions of the Solicitation Documents shall remain unchanged. This Addendum No. 4 is hereby made a part of the Solicitation Documents to the same extent as those provisions contained in the original documents and all itemized listings thereof.

Each Respondent is requested to acknowledge receipt of this Addendum No. 4 with the Bid Forms.
