### Roll-Off Rental Request Form

#### Roll Off Container Rental Rates\*

**\$321.25** per roll off container. NMGRT *will be charged to all services.*

Disposal of material will be charged at the current tipping rate. Pricing includes 30 days rental. If you decide you need more time you will be charged an additional \$10 per day. Must have an active account for service.

#### Guidelines

- Adequate space on private property away from overhead power lines, trees, and other obstructions is required for roll-off placement. If no adequate space on private property is available a permit must be obtained for the placement of the roll-off on the street. To obtain information on a Traffic Control permit contact the Traffic Division at 662-8396.
- The maximum legal weight limit for any roll-off is ten (10) tons.
- When discarding heavy material (i.e. concrete, shingles, etc.) the roll-off shall only be filled to half of capacity to ensure the 10-ton weight limit is not exceeded.
- Material discarded must be below or level with top of roll-off. Material shall not extend above the top or sides of the roll off container.
- Concrete or asphalt placed in the roll-off for recycling must be clean with 10% dirt or less and have a maximum thickness of 1' x 1'. No more than one cubic yard of concrete will be accepted for disposal as trash.
- The customer will be charged a \$105.00 service fee when the container cannot be picked up due to:
  - Overweight container
  - Overflowing container (*Material discarded must be below or level with top of roll-off. Material shall not extend above the top or sides of the roll off container*)
  - Blocked container
  - Same-day cancellation of a service
    - If renter is able to promptly fix the issue, enabling the roll-off to be serviced within 20 minutes of driver's arrival no additional service fee will apply.*
- 72-hour notification is required for placement and servicing of the roll-off.
- The roll off must be serviced a minimum of once every 30 days.
