- 1. Project Purpose and Scope:** Roadway infrastructure improvements which include removal of existing asphalt surface and base material. Re-compaction of subgrade and base material and installation of new asphalt surface on Alamo Road. For the six side streets (Capulin Road, Tsankawi Road, Oro Court, Cedro Court, Tsankawi Court, and Big Rock Loop South) processing, placing and compaction of existing pavement and installation of new asphalt surface. Reconstruction of driveways, sidewalks, curb ramps, fillets, and valley gutters will be completed on an as-needed basis.
- 2. Does this project support any of the Council's Strategic Goals? If so, which goal(s) apply?** Yes, Maintain and improve transportation and mobility and Maintain quality essential services and supporting infrastructure. Yes, two key Strategic Goals are being met with this project. Mobility by continuing to maintain and preserve our County transportation assets. Also, the Communication strategic goal is being accomplished by engaging the neighborhood and coordinating citizen involvement and feedback as a key part of the project development process.

3. Is this an approved CIP? Yes, it is part of the FY 2021 Transportation CIP, Street Priorities Based on Average Pavement Index (PCI).

4. What is the project location? Describe or supply map.

The project is located on North Mesa as shown in the map below and is accessed via San Ildefonso Road.



5. Who is your audience – who are you talking to? Adjacent residents and traveling Public.

6. Explain the steps for accomplishing the project and provide estimated timeframes for each step.

Anticipated Council Award date is in March 2021. Notice of Award will be issued the day after Council Award, with work anticipated to begin shortly after.

7. Does this project relate to projects in progress or in the future? Currently this FY 2021 CIP project is the only planned project for the North Mesa – Casa de Oro subdivision.

8. Project start and completion dates: Estimated Project Start on or before May 2021 and Completion November 2021

9. Project cost and funding source: Roadwork funded through FY2021 budgeted amount of \$1,687,000 CIP Fund with NMDOT State Grant Funding.

11. Describe the issues the public may have regarding the project: Residents and motorists should expect typical construction inconveniences such as noise, heavy equipment, traffic impacts, intermittent parking restrictions and access delays, potential detours, dust, etc.
